B.W. Miller, E.P. Hayes and John Schneider,
met at the time and place advertised, and
having viewed said Road to be vacated, and
are of the opinion that said Road is useless,
inconvenient and burdensome, and ought

At a Court of General Quarter Sessions of the
Peace held at Ebensburg, in and for said County,

on Tuesday the 24th day of October A.D. 1882,
before the Honorable Judges of said Court.

The petition of sundry citizens of Taylor Township
in said County was presented, representing, That a road, public,
has long been used by the public, to wit: over and above the term
of twenty one years, in said Township, running through the lands
of Daniel Dimond, and that said road is now become useless,
inconvenient and burdensome, and therefore praying the Court to
appoint proper persons to view and Vacate the same according to
the Act of Assembly in such case made and provided.

The Court upon due consideration had of the premises appointed
Samuel Miller Esq., John D. Snyder and E.C. Hayes, to view
the ground proposed to be Vacated, who, after having having first
given due and legal notice by printed or written advertisements, of
the time and place of meeting, and having been duly qualified
according to law to discharge the duties of their appointment with
Fidelity, shall proceed to view the same, and if all of said Viewers
view the same, and a majority of them agree that the said road
should be Vacated, they shall proceed to Vacate the same.

And the said Viewers shall make report of their proceedings herein
to the next Court of Quarter Sessions of the Peace to be held for
said County, together with a plot or draft of said road Vacated,
the courses and distances, and references to the improvements
through which the same passes; and in which report they
shall state distinctly, that they had been sum or affirmed
according to law.
