held at Greensburg in the the said County, on the Saturday of
June A. D. 1893, before the Honorable the Judges of the same
Court: Upon the petition of divers inhabitants of the township of Portage Summerhill
in the said County, setting forth that they labor under inconvenience for want of a

public road or highway, to lead from
a point in a public road leading from Portage via
Portage Twp. to Frankstown Road at a point
near residence of Mr. Sparks in the Township of Portage
and to end in a public road leading from J. L. Kup-
fer's Grist Mill to Frankstown road at a point
near h. 6 School House in Summerhill Twp.

and therefore praying the Court to appoint proper persons to view and lay out the
same according to law. The Court upon due consideration had of the premises, do
order and appoint John Watt SURVEYOR,

and Lucas Sheline & W. H. May

VIEWERS, to view the ground proposed for said
road, and if they view the same, and shall agree that there is occasion for such
road, they shall proceed to lay out the same, having respect to the shortest distance
and the best ground for a road, and in such manner as shall do the least injury to
private property, and also be, as far as practicable, agreeable to the desire of the
petitioners, and that they make a report of their proceedings to the next Court
of Quarter Sessions to be held for said County, stating particularly whether they
judge the same necessary for a public or private road, together with a plot or draft
thereof, and the courses and distances, and references to the improvements through
which it may pass.

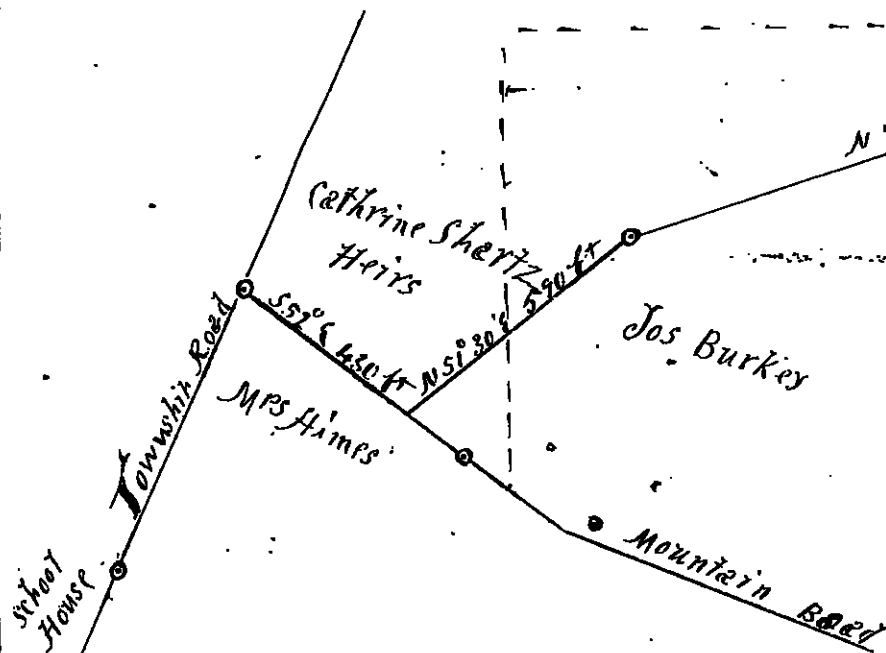

Beginning at a point or stake in Township road opposite the School House in Township of Sumnerhill and running west with said road $N 23^{\circ} W$ 632 ft to a stake at the Junction of said road with the public road leading to Bedford County thence along said road $S 52^{\circ} E$ 480 ft to a point East of the residence of Joseph Buckley thence through lands of Catherine Shartz Hays and terminating in lands of Jos Buckley $N 51^{\circ} 30' E$ 590 ft thence through lands of Jos Buckley and Henry W Cornick and terminating in lands W^{rs} Christmanwood $N 70^{\circ} E$ 2480 ft, thence through lands of said W^{rs} Christmanwood and Jeremiah Bates and B. W^c Polgar
