NOTE.—"It shall be the duty of all persons appointed in the several countles of this Commonwealth to view and review any public or land such location may be made releases from all claims for damages that might arise from the opening of such road or the building of such bridge; and in every case where said viewers shall fall to procure such releases, and it shall appear to them that any damages will same, together with all releases obtained, to the Court of Quarter Sessions, and the damages so assessed shall be conclusive, or may be subject to appeal, review or modification, as may be provided by existing laws in the different countries of this Commonwealth?
