and at that point in said line to connect with a proposed new
road leading from Conemaugh Furnace to the same point in said
line, in Westmoreland County.

Your petitioners therefore pray the Court to appoint
proper persons to view and lay out the same, and they will ever
pray etc.

To the Hon Judge of the Court of
Quarter Sessions of the Peace in within
order named.

We the undersigned persons
appointed by the within order of Court
to view and lay out the road therein
mentioned. Report that public notice
having been given, by written notice
of the time and place when and
where they would meet for the
purpose of discharging their duties
according to law, and that having been
first severally sworn or affirmed
in pursuance of the said order we
have viewed and laid out and do
return for public use the following
road to wit:—Beginning at a point
where Vine Street intersects Shindon
Street in the Village of Shindon
Lower Yoder Township, and running
west to the County line separating
Leamington and Westmoreland Counties
near Bonemans Farm, as shown
by plan or draft herewith annexed.
And we further report that we have
endeavored to obtain releases from the
persons through whose land the
road is located, that we have obtained
the releases herewith annexed, from

B. Shindler and Louis Wether, that
Mrs Moses McElaine, Mrs James Felix
McDonoughy Hiers and Emerson Hiers
refuse (those who were seen) to sign a
release although they have no serious
objection to the construction of said
road; these being the only persons
through whose land the road is
located, and they further report that
they have considered the damages
by reason of the opening of said
road and find and report, that
the advantages to all persons
concerned are equal to their dis-
advantages, with reference to the
improvements through which said
road passes a plot or draft is here-
with annexed.

At a Court of Quarter Sessions of the Peace of the County of Cambria held at Ebensburg in the said County, on the 21st day of January A. D. 1895, before the Honorable Judge of the said Court: Upon the petition of divers inhabitants of the township of Lower Yoder in the said County, setting forth that they labor under inconvenience for want of a public road or highway, to lead from Sheridan Street in the Village of Sheridan, where the present location of what is now known as Vine Street intersects with said Sheridan Street to a point in the line dividing Cambria County and Westmoreland County, about eight hundred feet south of the Conemaugh River and at that point in said line to connect with a proposed new road leading from Conemaugh Furnace to the same point in said line in Westmoreland County

and therefore praying the Court to appoint proper persons to view and lay out the same according to law: The Court upon due consideration had of the premises, do order and appoint Charles H. Ogle SURVEYOR and J. H. Black and Charles C. Kuhn

VIEWERS, to view the ground proposed for said road, and if they view the same, and shall agree that there is occasion for such road, they shall proceed to lay out the same, having respect to the shortest distance and the best ground for a road, and in such manner as shall do the least injury to private property, and also be, as far as practicable, agreeable to the desire of the petitioners, and that they make a report of their proceedings to the next Court of Quarter Sessions to be held for said County, stating particularly whether they judge the same necessary for a public or private road, together with a plot or draft thereof, and the courses and distances, and references to the improvements through which it may pass.

NOTE.—"It shall be the duty of all persons appointed in the several counties of this Commonwealth to view and review any public or private road or bridge, if they shall decide in favor of locating said road or bridge, to endeavor to procure from the persons over whose land such location may be made releases from all claims for damages that might arise from the opening of such road or the building of such bridge; and in every case where said viewers shall fail to procure such releases, and it shall appear to them that any damages will be sustained, it shall be their duty to assess the damages and make report there of signed by a majority of their number, and return the same, together with all releases obtained, to the Court of Quarter Sessions, and the damages so assessed shall be conclusive, or may be subject to appeal, review or modification, as may be provided by existing laws in the different counties of this Commonwealth."

"The persons appointed as aforesaid shall view such ground, and if they shall agree that there is occasion for a road, they shall proceed to lay out the same, having respect to the shortest distance, and the best ground for a road, and in such manner as shall do the least injury to private property, and also be, as far as practicable, agreeable to the desire of the petitioners."

"The viewers, as aforesaid, shall make report, at the next term of said Court, and in the said report shall state particularly: first, who of them were present at the view; second, whether they were severally sworn or affirmed; third, whether the road desired be necessary for a public or private road; they shall also annex and return to the Court a plot or draft thereof, stating the courses and distances, and noting briefly the improvements through which it may pass; and, whenever practicable, the viewers shall lay out the said roads at an elevation not exceeding five degrees (except at the crossing of ravines and streams), where, by moderate filling and bridging, the declination of the road may be preserved within that limit."
