QUARTER SESSIONS OF CAMBRIA COUNTY, PENNSYLVANIA.

The undersigned viewers appointed by your Honor as shown by the annexed order, to view a road in the Townships of Allegheny and Galitzin, in said County of Cambria, leading from George Greses to Storms Mill, and to report to the Court upon the matter of widening the same, respectfully represent:

That having given due notice of the time and place of meeting by posting at least ten hand bills in public places in the vicinity of said road for ten days prior to the time of their meeting, they met first in the office of B. W. Litzinger in the Borough of Loretto, in said County of Cambria on Monday the 28th day of November 1904 at 9 o'clock A.M. to enter upon the performance of their duties, and having each been sworn to perform the duties of his appointment impartially and according to the best of his judgment, they then proceeded to view the said road, and having given said road a careful examination and investigation, and finding the same encroached upon at certain places, as shown on a draft hereto attached, they are of the opinion that the said road should be widened so that it will be of the width of thirty-five feet at all points along the said road, which road as shown on said draft is described as follows:

BEGINNING at a point at what was formerly known as "George Greses" being a point where the road herein described intersects with another road and also a point from which the continuation of the road herein described leading in a North Easterly direction has been vacated by order of Court, and extending thence South thirty-eight degrees West seven hundred and fifty feet, thence South forty-one degrees West five hundred feet; thence South forty-three degrees West five hundred feet; thence South forty-nine degrees West four hundred feet; thence South forty-two degrees West four hundred and fifty-nine feet; thence South forty-seven degrees forty-five minutes West three hundred feet; thence

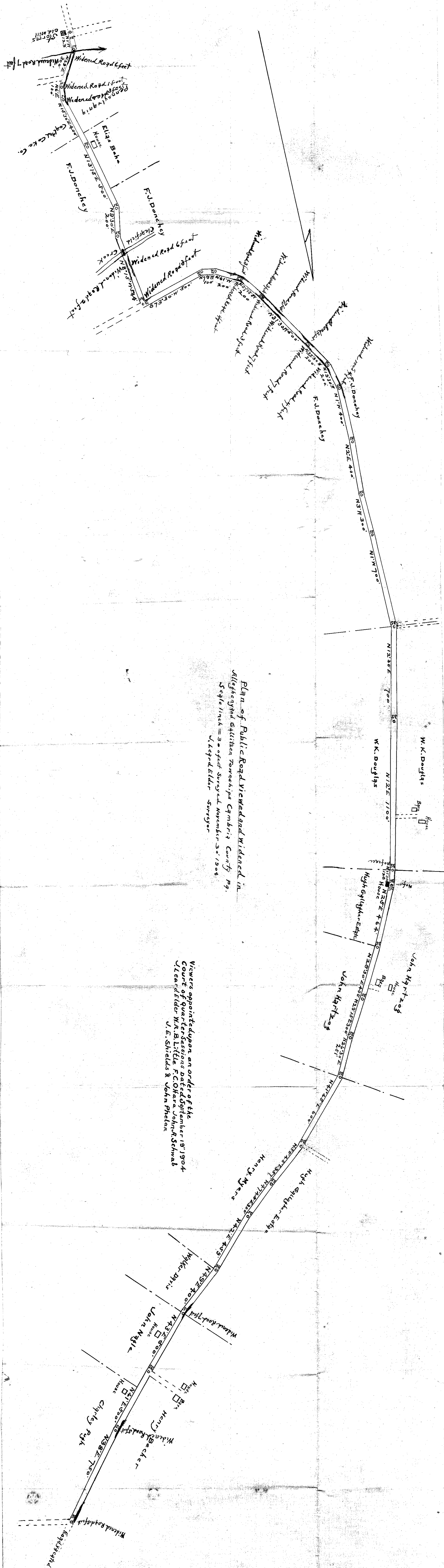
South fifty degrees forty-five minutes West three hundred and fifty seven feet;thence South forty-one degrees forty-five minutes West six hundred feet;thence South twenty-six degrees thirty minutes West two hundred and fifty one feet;thence South twenty-nine degrees fifteen minutes West three hundred feet;thence South twenty-eight degrees thirty minutes West four hundred feet;thence South twenty-five degrees West four hundred and sixty-four feet;thence South eleven degrees thirty minutes West one hundred and twenty eight feet;thence South twelve degrees West eleven hundred feet;thence South twelve degrees thirty minutes West seven hundred feet;thence South one degree East seven hundred feet;thence South three degrees East three hundred feet; thence South two degrees West four hundred feet;thence South one degree East four hundred feet;thence South thirteen degrees thirty minutes East two hundred feet;thence South thirty-two degrees thirty minutes East two hundred feet;thence South thirty-one degrees thirty minutes East five hundred feet;thence South thirty-seven degrees fifteen minutes East two hundred feet;thence South sixty-one degrees East two hundred feet;thence South seventy-nine degrees East one hundred feet;thence North seventy-three degrees thirty minutes East five hundred feet;thence South eight degrees fifteen minutes East five hundred and forty-four feet;thence South nine degrees thirty minutes West two hundred feet;thence South thirteen degrees fifteen minutes West five hundred feet;thence South fifteen degrees thirty minutes West four hundred feet;thence South six degrees West one hundred feet;thence South twenty-three degrees West three hundred feet; and thence South one degree West one hundred and twenty three feet to Storms Mill.

At a Court of Quarter Sessions of the Peace of the County of Cambria held at Ebensburg in the said County, on the Nineteenth day of September A. D. 1904, before the Honorable Judge of the said Court: Upon the petition of divers inhabitants of the Townships of Allegheny and ^{Gallitzin}, in the said County, setting forth that ~~they labor under inconvenience for want of a road or highway to lead from~~ a public road was laid out leading from George Creses to Storms mill, as shown on the proceedings thereof entered in Road Docket No. 1 at page 50 et seq., and that they labor under great inconvenience by reason of said public road being too narrow in places, the same having been in many places long since encroached upon rendering the same too narrow for the proper travel of the public

and therefore praying the Court to appoint proper persons to ^{widen} view and ~~view~~ the same according to law. The Court upon due consideration had of the premises, do order and appoint J. Leard Elder, ~~B. W. Fitzinger~~, W. A. B. ~~Little~~, F. C. O'Hara, John A. Schwab, J. E. Shields and John Phelan

VIEWS, to view the ground proposed for said road, and if they ^{widen} view the same, and shall agree that there is occasion for such road, they shall proceed to ~~lay out~~ the same, having respect to the shortest distance and the best ground for a road, and in such manner as shall do the least injury to private property, and also be, as far as practicable, agreeable to the desires of the petitioners, and that they make a report of their proceedings to the next Court of Quarter Sessions to be held for said County, stating particularly whether they judge the same necessary for a public or private road, together with a plot or draft thereof, and the courses and distances, and references to the improvements through which it may pass.

NOTE. "It shall be the duty of all persons appointed in the several counties of this Commonwealth to view and review any public or private road or bridge, if they shall decide in favor of locating said road or bridge, to endeavor to procure from the person or persons over whose land such location may be made releases from all claims for damages that might arise from the opening of such road or the building of such bridge; and in every case where said viewers shall fail to procure such releases, and it shall appear to them that any damages will be sustained, it shall be their duty to assess the damages and make report thereof signed by a majority of their number, and return the same, together with all releases obtained, to the Court of Quarter Sessions, and the damages so assessed shall be conclusive, or may be subject to appeal, review or modification, as may be provided by existing laws in the different counties of this Commonwealth."

"The persons appointed as aforesaid shall view such ground, and if they shall agree that there is occasion for a road, they shall proceed to lay out the same, having respect to the shortest distance, and the best ground for a road, and in such manner as shall do the least injury to private property, and also be, as far as practicable, agreeable to the desire of the petitioners."

"The viewers, as aforesaid, shall make report, at the next term of said Court, and in the said report shall state particularly: first, who of them were present at the view; second, whether they were severally sworn or affirmed; third, whether the road desired be necessary for a public or private road; they shall also annex and return to the Court a plot or draft thereof, stating the courses and distances, and noting briefly the improvements through which it may pass; and, whenever practicable, the viewers shall lay out the said roads at an elevation not exceeding five degrees (except at the crossing of ravines and streams), where, by moderate filling and bridging, the declination of the road may be preserved within that limit."
