A petition was filed by citizens of Jackson Township suggesting the necessity of a public road to begin on Township Route No. 437 at a point 1522 feet west of the Nanty-Glo Borough line and ending on U. S. Route No. 22 at a point 2130 feet eastward from its intersection with Township Route No. 428 and 4238 feet westward from Mundy's Corner.

In accordance with the prayer of said petition, viewers were appointed and reported that the road between the termini set forth in the petition was necessary, and accordingly laid out a road between said termini.

Exceptions were filed to the report of viewers by the Supervisors of Jackson Township, who afterwards, however, filed a petition for a review, to which they were entitled as a matter of right. The reviewers made their report, in which they approved the report of the viewers, but recommended the building of but 1328 feet of the road on the one end and 1383 feet on the other end, "leaving a balance of 2312 feet to be built when it becomes necessary." Exceptions were filed by the original petitioners to the report of the reviewers, and we have before us the disposition of these exceptions.

We do not believe it is necessary at this time to dis-

cuss the merits of the exceptions filed by the Supervisors to the viewers' report or by the original petitioners for view to the reviewers' report, except to say that the report of the reviewers may not be approved in its present form. The court may not condition its approval by ordering only a part of the road petitioned for to be opened and defer the opening of the other part until After a public road has been laid out, the duty further order. of the Supervisors to open and maintain it begins immediately: Benzinger Township Road, 115 Pa. 436.
