RESOLUTION AND ORDINANCE OF SUPERVISORS

At a meeting of the Supervisors of Allegheny Township, Cambria County, Pennsylvania, held on July 2, 1948, and at a meeting of the Supervisors of Clearfield Township, Cambria County, Pennsylvania, held on July 2, 1948, to pass upon the advisability of abandoning certain portions of the relocated State Highway Route No. 221, Section 9, in District 9, running between the division line of Allegheny Township and Clearfield Township, the two Boards of Supervisors passed a Resolution resolving to meet at a joint session of said Boards on said Route No. 221 at the County Bridge West of the Ashville line across Clearfield Creek on said Route, on the 27th day of July, 1948, at 1:00 P.M. for the purpose of determining further action.

On the said 27th day of July, 1948, the Supervisors of Allegheny Township, comprised of Regis T. Seymour, Chairman, Ebensburg R.D., Pa.; Michael Driscoll. Loretto R.D., Pa.; and Charles Smithbower, Loretto R.D., Pa., met on said bridge with the Board of Supervisors of Clearfield Township composed of L. A. Cretin, Chairman, Patton R.D., Pa.; W. J. Bender, Patton R. D. and A. Marra, Dysart R.D., Pa., at which point a meeting was held and after a hearing, it was ascertained that there were no objections to the abandonment of said portions of State Highway Route No. 221 and that the portions of said State Highway Route No. 221, as relocated by the State Highway Department and as shown by a drawing or plan attached hereto and made a part hereof, would serve the people living along said road better than the old portions of the road to be abandoned and upon inquiry and investigation, it was ascertained that there were no damages claimed by anyone as a result of the abandonment of said highway Route No. 221.

It was therefore resolved and ordained at the said Board meeting of the Allegheny Township Board of Supervisors and the Clearfield Township Board of Supervisors that the two portions of said highway Route No. 221 marked on said draft or plan for abandonment, viz: From Station No. 848 \neq 36.48 on the

Ashville end of said highway for a distance of 1363.52, or 0.2582 of a mile abutting the properties of F. J. Kelly, John Migelicz, Mrs. Dartkiewick and Stanley Harricivet be and the same is abandoned and discontinued and the adopted portion of said State Highway Route No. 221 as shown on the draft annexed hereto be substituted as a portion of said Highway Route No. 221 in lieu thereof. The new and substituted portion of the State Highway Route No. 221 adjoins the property on the North by the Clearfield Bituminous Coal Corporation. Charles F. Moran Estate, and C. E. Stoy and Ruth Stoy.

It was further resolved and ordained that that portion on the West as shown on said draft of Route 221 marked for abandonment from Station No. 876 \$\display\$ 00 for a distance of 2700 feet or 0.5114 of a mile adjoining the properties on the South side of Joseph Sherry, Raymond G. McCoy, Leo J. Johnston and Elizabeth Johnston, all of Allegheny Township, be and the same is abandoned and discontinued as a portion of said Highway Route No. 221 and the new or substituted portion of said Highway Route No. 221 as shown on said draft or plan be and the same is adopted in lieu of said vacated portion.

The abandoned and relocated portions of said Route No. 221, Section 9, District 9 through Allegheny Township and Clearfield Township was approved by the Governor of the Commonwealth of Pennsylvania on August 8, 1948.

That it was further resolved at the joint session of the respective Supervisors of Allegheny Township and Clearfield Township held on July 27, 1948, that this report and return be filed at the office of the Clerk of Court of Cambria County, Pennsylvania, in compliance with the Act of Assembly, No. 567 on July 10, 1947, and all expenses incident to the preparation and filing of said report be paid jointly by the Townships of Allegheny and Clearfield.

It was further directed that all notices of abandonment and relocation of the portions of said Highway Route No. 221 in Section 9, District 9 of Allegheny Township and Clearfield Township, Cambria County, Pennsylvania, as shown by the draft attached hereto be given in accordance with the provisions of said Act of Assembly, and such notice shall state the fact of the passage or approval of the ordinance and the date or approval of the passage thereof.
