That the said Supervisors of West Taylor Township have passed a Resolution, adopting project as a Township Highway and authorizing this Petition asking your Honorable Court's approval, a certified copy of the said Resolution of the Township Supervisors is hereto a ttached and made a part hereof as well as a blue print of a survey made by H. J. Bossler together with the Releases of the adjoining property owners.

Therefore, your Petitioners pray, your Honorable Court, to approve the said adoption of the said highway as a Township Highway leading from Cardiff Street to Cooper Avenue and said Right-of-way to be forty feet in width between property lines, and they will forever pray.
