- 1. That a Petition to open and lay out a public road located wholly within the Township bearing signature of a majority in interest of the owners of property through whose land the proposed road passes or upon whose land it abuts, was presented to the Township Supervisors at a regular meeting. A copy of the Petition being hereto attached and marked Exhibit 1.
- 2. That ten days notice to the property owners affected thereby of the time and place when and where all parties interested might be heard was given by the Township Supervisors. A copy of the said notice being hereto attached and marked Exhibit 2.
- 3. That after hearing on the said Petition and after consideration by the Township Supervisors, a Resolution of the Township Supervisors was duly passed to exercise the power conferred upon the said Township Supervisors by Act of the General Assembly to open and lay out said public road and fixing the width thereof at thirty-three feet. A copy of the said Resolution being hereto attached and marked Exhibit 3.
- i. The Township Engineer was directed to make a survey of the proposed road and prepare a draft noting the improvements along the line thereof and the names of the owners of property through which the said road passes or upon which it abuts. A copy of the said draft being attached hereto and marked Exhibit 4.

- 5. That after the passage of the said Resolution mentioned in Paragraph 3 of this report, notice thereof was given by handbills posted in conspicuous places along the line of the proposed public road. A copy of the said handbill being hereto attached and marked Exhibit 5.
- 6. That an agreement has been made between the Township Supervisors and the parties through whose property the proposed public road passes or upon whose land it abuts, whereby compensation for any damages caused by the opening and laying out of the said road have been waived. A copy of the waiver, signed by a majority of the parties in interest being hereto attached and marked Exhibit 6.
