Opinion by Evans, P. J.

This case arises out of a proceeding to have damages assessed alleged to have been sustained by a change of grade in the improvement of Gilbert Street, which is an ordinary dirt road in Lower Yoder Township. Four exceptions were filed, the first alleging that the presentation of the Petition of the Viewers was premature. This exception, however, it is not necessary to discuss, for the reason that the matter is controlled by the reasons raised in the second, third and fourth exceptions. These last mentioned exceptions, raise the question as to whether or not there is any statutory authority for a proceeding to have damages assessed for change of grade in a Township road.

Counsel for the petitioner has not seen fit to submit any brief upon the question arising so that we are limited to such authority as has been presented by the exceptant and as we have discovered by our own efforts.

It is well settled that the only powers which Townships possess are derived from Statute, Union Township vs. Gibbony, 94 Pa., 534.

A Township is not liable for damages to the adjoining property make owner in the case of a change of grade in a public road made by the Supervisors, Shoe vs. Nether Providence Township, 3 Superior, 137.

In the opening and improvement of public highways land owners are entitled only to such redress as is given by Statute, State Highway Route No. 272, 265 Pa., 369.

Lower Yoder Township is a Township of the second class.

An examination of the Statutes so far as we have been able to investigate them, fails to show any provision whereby a land owner in a Township of the second class may be compensated for of grade a change/in a Township road.

We therefore enter the following decree:

And now, January 12, 1925, after due consideration, the second, third and fourth exceptions are sustained and the proceedings dismissed.
