

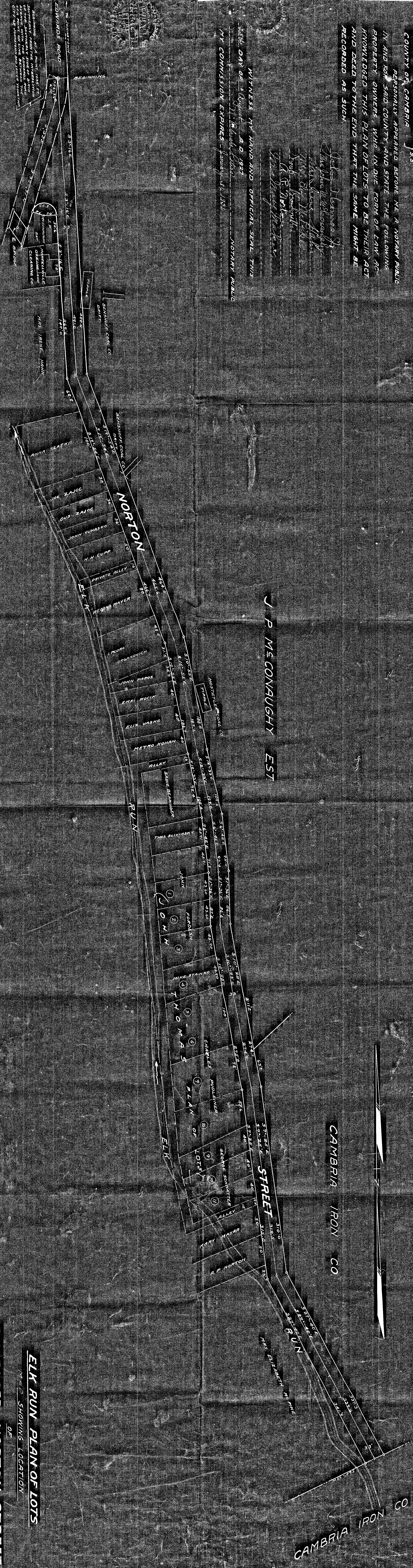

The Board of Supervisors of Lower Yoder Township respectfully represents:

1. That your petitioners desire to accept as a Public Highway in the said Township, Norton Street which is thirty-three (33) feet in width, as dedicated to public use by a plot known as Elk Run Plan of Lots, duly recorded in the office for the recording of deeds, etc., in and for Cambria County in Plat Book Vol. 2 at page 156.
2. A proper description of said Street is contained in the Certified Attested Copy of Resolutions hereto attached.
3. A Resolution, a certified copy of which is hereto attached, at a duly called meeting of the Board of Supervisors of Lower Yoder Township held on the 6th day of September, A. D., 1927, was adopted by a unanimous vote of the Board of Supervisors, duly recorded and entered upon the minutes of said Board.
4. A copy of Elk Run Plan of Lots showing Norton Street is hereto attached.

Wherefore, your petitioners pray your Honorable Court to consent to the adoption of said Street as a Public Highway of the Township of Lower Yoder,

CERTIFIED COPY OF RESOLUTION.

WHEREAS, John Thomas, Jr., Mrs John M. McConaughy, Irene Hahn, Elizabeth McPike, Frank Grandinetti, A. P. Norton and Mary Maker have dedicated to public use by a plot duly recorded in the office of the Recorder of Deeds, in and for the County of Cambria and State of Pennsylvania, in Plat Book Vol. 2 at page 156, a Thirty-three (33) foot wide street situate in the Township of Lower Yoder, County of Cambria and State of Pennsylvania, and hereinafter more particularly described known as Norton Street as shown on the Elk Run Plan of Lots, and

WHEREAS, it is the desire of the Board of Supervisors of the Township of Lower Yoder with the consent of the Court of Quarter Sessions of Cambria County to accept said Street as a public highway of said Township,

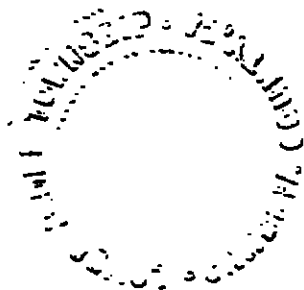
NOW, THEREFORE, BE IT RESOLVED AND IT IS RESOLVED, That Norton Street in the Township of Lower Yoder, the center line of which begins at a point Ten Hundred Thirty-nine (1039) feet Southerly from the intersection of the Southerly side of Burch Avenue in the City of Johnstown, County of Cambria and State of Pennsylvania, with the Edwards Road, at a point on line between the City of Johnstown and Lower Yoder Township, thence extending South three (3°) degrees sixteen (16') minutes East four hundred ninety-one (491) feet to a point; thence South nineteen (19°) degrees fifty-four (54') minutes East four hundred sixty-five and six-tenths (465.6) feet to a point; thence South ten (10°) degrees fifty-five (55') minutes East one hundred eighty-seven and seven-tenths (187.7) feet to a point; thence South twelve (12°) degrees thirty-three (33') minutes East one hundred nine (109) feet to a point; thence South six (6°) degrees forty-two (42') minutes East ninety-three and four-tenths (93.4) feet to a post; thence South one (1°) degree thirty-six (36') minutes East eighty-

six and six-tenths (86.6) feet to a point; thence South ten (10°) degrees twenty-eight (28') minutes East two hundred seventy-four and nine-tenths (274.9) feet to a point South seven (7°) degrees Twenty-five (25') minutes East three hundred twelve and five tenths (312.5) feet to a point; thence South twenty-seven (27°) degrees forty (40') minutes East three hundred thirty-nine and six tenths (339.6) feet to a point, and having a width of thirty-three (33) feet as shown on the Elk Run Plat of Lots laid out by Fetterman Engineering Company, July 1st, 1927, and which Plan is recorded in Cambria County in Plat Book Vol. 2 at page 156, be and the same is hereby accepted as a public highway of the Township of Lower Yoder.

BE IT FURTHER RESOLVED AND IT IS RESOLVED, That a petition be presented to the Court of Quarter Sessions of Cambria County by the Township of Lower Yoder, containing a certified attested copy of these Resolutions and asking the consent of the Court of Quarter Sessions of Cambria County to the acceptance of said Street as a Public Highway of the Township of Lower Yoder and upon the endorsement of the consent of the said Court, that the said Petition and certified attested copy of resolution be filed with the Clerk of the Court of Quarter Sessions of said County.

I hereby certify that the foregoing is a true and correct copy of a Resolution adopted by the Board of Supervisors of the Township of Lower Yoder, County of Cambria, at a duly called meeting held on the 6th day of September, A. D., 1927, by the unanimous vote of all the Supervisors, duly recorded and entered upon the Minutes of said Board.
