

CERTIFIED COPY OF RESOLUTION AS AD CPTED UNANIMOUSLY — FULL MEMBERSHIP OF BOARD OF SUPERVISORS BEING PRESENT AT MEETING OF SUPERVISORS OF UPPER YODER TOWNSHIP, CAMBRIA COUNTY, PENNSYLVANIA, DULY HELD ON THE 30th DAY OF AUGUST, A.D. 1935.

WHEREAS, a petition was presented by all the owners in fee of all the lots abutting on Congress Avenue from Bronx Street to Sell Street, in the Township of Upper Yoder, Cambria County, Pennsylvania, said streets having been designated to public use by Plot known as "Rosemont Addition Plan of Lots" as laid out for F. W.Otto by S. E. Dickey & Co., Civil and Mining Engineers, dated May, 1912, and recorded in the Recorder's office of Cambria County, Pennsylvania, in Plat Book Vol. \_\_\_\_\_, page \_\_\_\_\_; and

WHEREAS, said petitioners desire that the township shall accept a portion of said Congress Avenue from Bronx Street to Sell Street as a public thoroughfare to be incorporated into the system of township high-ways; and

WHEREAS, all of the abutting owners have executed a release of and from all manner of damages, etc., as attached hereto; and

WHEREAS, it is the desire of said supervisors to accept the above described highway as a public thoroughfare;

NOW, BE IT RESOLVED,

That a portion of Congress Avenue described as follows: Beginning at the intersection of Bronz Street, a public highway, thence North 52 degrees 09 minutes West, 634.97 feet to the intersection of Sell Street, an improved public highway, including the additional width of fifteen (15) feet of lots 12 and 15 in the Rosemont Addition Plan of Lots, all within the Township of Upper Yoder; said Plan being recorded in the Recorder's office , be opened and accepted as aforesaid in Plat Book Vol. , page a public thoroughfare or public highway of the Township of Upper Yoder, County of Cambria and State of Pennsylvania, as heretofore dedicated to public use on the Plan of Rosemont Addition as laid out for F. W. Otto by S. E. Dickey & Co., Civil and Mining Engineers, dated May 12, 1912, recorded in Plat Book Vol. , and a portion of said Plan is attached hereto, being , page hereby approved.

BE IT FURTHER RESOLVED, that the necessary grading and drainage shall be as determined by the Township Engineer;

BE IT FURTHER RESOLVED, that this action, with the consent of the Court of Quarter Sessions of Cambria County, be recorded in the Recorder's Office of Cambria County, and then filed with the Clerk of Quarter Sessions of Cambria County;

BE IT FURTHER RESOLVED, that a portion of Congress Avenue from Bronx Street to Sell Street as hereinabove described shall then become a part of the public highway system of the said Township of Upper Yoder, Cambria County, Pennsylvania, and that the costs of these proceedings be paid by the said Township of Upper Yoder, Cambria County, Pennsylvania.

Unanimously adopted at meeting duly held this 30th day of August. A.D. 1935.
