BE IT FURTHER RESOLVED, that this action, with the consent of the Court of Quarter Sessions of Cambria County, Pennsylvania, be recorded in the Recorder's office of Cambria County, and then filed with the Clerk of Quarter Sessions of Cambria County;

BE IT FURTHER RESOLVED, that Slagle Street from Valley Pike to Center Street and Center Street from Hill Alley to angle at dividing line between lots Nos. 2 and 3 extended, as hereinabove described, shall then become a part of the public highway system of the said Township of Upper Yoder, Cambria County, Pennsylvania, and that the costs of these proceedings be paid by the said Township of Upper Yoder, Cambria County, Pennsylvania.
