Now, January /2, 1937, the within petition having been read and considered, the Court hereby gives its consent that Capital Avenue, a dedicated Street on the Plan of "ROSEMONT" in Upper Yoder Township, Cambria County, Pennsylvania, be accepted as a public highway; and it is further ordered and directed that the said Capital Avenue shall forthwith be and become a part of the public highway system of the Township of Upper Yoder, Cambria County, Pennsylvania; and be it still further ordered and directed that this proceeding be recorded in the Court of Quarter Sessions of Cambria County, Pennsylvania.

EXHIBIT A

RESOLUTION

ACCEPTING CAPITAL AVENUE, A DEDICATED STREET IN THE TOWNSHIP OF UPPER YODER, CAMBRIA COUNTY, PENNSYLVANIA, AS A PUBLIC HIGHWAY

WHEREAS, the Plan of Lots in Upper Yoder Township, Cambria
County, Pennsylvania, known as "ROSEMONT", contains a plan of dedicated roads,
streets, lanes and alleys, which plan was adopted, approved and recorded prior
to May 1, 1933, in Plot Book, Vol. at page , a print of
said Plan being hereto attached, made part hereof and marked "EXHIBIT A"; and
WHEREAS, such roads, streets, lanes and alleys are shown on
said Plan as dedicated to such use; and

WHEREAS, the said roads and streets are not less than thirtythree (33) feet in width, and the said lanes and alleys are not less than fifteen (15) feet in width; and

WHEREAS, the residents and owners of lots abutting on said Capital Avenue, as shown on said plan, "Exhibit A", have petitioned the Supervisors of said Upper Yoder Township, petitioning that said Capital Avenue be accepted as a public highway, and releasing the said Township from any damages that may result by reason of said acceptance and the opening, grading, draining, improving and maintaining said Capital Avenue; and said petition and release are hereto attached, made part hereof and marked "EXHIBIT B".

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Upper Yoder Township, Cambria County, Pennsylvania, and it is hereby resolved by the authority of the same, that Capital Avenue on said plan, a dedicated highway forty (40) feet in width, beginning at a intersection of Sell Street, a public highway, thence South 52° 42' East three hundred sixty-five (365) feet to an angle point; thence South 62° 24' Bast three hundred ninety-four (394) feet to the intersection of the southerly side of an unnamed dedicated alley fifteen (15) feet in width, shall be and the same is hereby accepted as a public highway, subject to the consent of the Court of Quarter Sessions of said Cambria County; and

BE IT FURTHER RESOLVED that a petition be presented and filed with the said Court of Quarter Sessions praying that the said Capital Avenue be accepted as a public highway, in accordance with the Act of 1935, P. L. 1299, section 1147.


