**PETITION FOR THE ACCEPTANCE OF GRANGER DRIVE
AND PORTIONS OF WILLETT DRIVE IN THE
TOWNSHIP OF LOWER YODER**

TO THE HONORABLE, THE JUDGES OF THE ABOVE NAMED COURT:

The petition of the Board of Supervisors of the Township of
Lower Yoder respectfully represents:

(1) That the Board of Supervisors did on the ²⁴30 day of
November, 1954, at 7:30 P. M., at a special meeting, accept the
following streets in the Township of Lower Yoder, which streets are as
follows:

- (a) WILLETT DRIVE - Beginning at Goucher Street
to Minno Drive adjoining Westmont Borough, a
distance of approximately 475 feet in length and
being the northerly half thereof, fifty feet wide;
thence from Minno Drive in a westerly direction
for the full width thereof, varying from fifty to
sixty feet to a distanced approximately 710 feet
in length, to Lot No. 347; thence in a westerly
and northerly direction a distance of approximately
745 feet in length to the northerly line of Granger
Drive.
- (b) GRANGER DRIVE - Beginning at the intersection
thereof with Willett Drive, containing a width of
fifty feet and extending 1,020 feet to Minno Drive.

as appears by a copy of the Resolution hereto attached, made part hereof
and marked "Exhibit A".

WHEREFORE, your petitioner prays your Honorable Court to
give its consent to the acceptance of Granger Drive and portions of Willett

Drive, described in the Resolution hereto attached, as a public highway or street in the said Township.

**RESOLUTION TO ACCEPT GRANGER DRIVE AND PORTIONS
OF WILLETT DRIVE IN THE TOWNSHIP OF LOWER
YODER**

WHEREAS, Westmont Enterprises, Inc., filed a development plan of certain lots located in the Township of Lower Yoder, which plan was laid out by F. L. Gardner, R. P. E. on December 29, 1952, and approved by the Johnstown Planning Committee on April 9, 1953, and approved by the Township of Lower Yoder on October 5, 1953, which plan was recorded in the Office of the Recorder of Deeds in and for Cambria County on October 9, 1953, in Plat Book Vol. 5, Page 37; and

WHEREAS, in the said plan there is laid out Granger Drive and Willett Drive; and

WHEREAS, it is the intention and desire of the Supervisors of the Township of Lower Yoder to accept Granger Drive and portions of Willett Drive as shown in the said dedicated plan;

NOW, THEREFORE, BE IT RESOLVED, that the Township of Lower Yoder accepts the following streets or avenues:

- (a) WILLETT DRIVE - Beginning at Goucher Street to Minno Drive adjoining Westmont Borough, a distance of approximately 475 feet in length and being the northerly half thereof, fifty feet wide; thence from Minno Drive in a westerly direction for the full width thereof, varying from fifty to sixty feet to a distance of approximately 710 feet in length, to Lot No. 347; thence in a westerly and northerly direction a distance of approximately 745 feet in length to the northerly line of Granger Drive.
- (b) GRANGER DRIVE - Beginning at the intersection thereof with Willett Drive, containing a width of fifty feet and extending 1,020 feet to Minno Drive.

BE IT FURTHER RESOLVED, that the Township Solicitor be authorized to make written report thereof to be presented and filed in the Office

of the Clerk of Courts of the Court of Quarter Sessions of Cambria County,
Pennsylvania.

AND BE IT FURTHER RESOLVED, in accordance with the
provisions of the Act of Assembly in such case made and provided that any
citizen or freeholder of the Township may, within thirty days after the filing
of the report of the Supervisors, file exceptions to the report, together with
a petition for a review.

ORDER

NOW, the 6 day of December, 1954, the within
Petition having been read and considered, the Court hereby gives its consent

- (a) WILLETT DRIVE - Beginning at Goucher Street to Minno Drive adjoining Westmont Borough, a distance of approximately 475 feet in length and being the northerly half thereof, fifty feet wide; thence from Minno Drive in a westerly direction for the full width thereof, varying from fifty to sixty feet to a distance of approximately 710 feet in length, to Lot No. 347; thence in a westerly and northerly direction a distance of approximately 745 feet in length to the northerly line of Granger Drive.
