RESOLUTION

ACCEPTING THE LAND DEDICATED BY DEED OF WALTER E. WALKER, et ux, et al, AS A PUBLIC ROAD.

WHEREAS, Walter E. Walker, et ux, et al, by deed dated the 26th day of Earch, 1960, and recorded in the Recorder of Deeds Office in and for Cembria County, Pennsylvania, on March 29, 1960, as Document No. 1355 dedicated the hereinafter described parcel of land in Jackson Township for road purposes; and

THEREAS, the Supervisors of Jackson Township have decided to accept the said dedication and declare the same a public road or street in Jackson Township.

RESOLVED, that the aforesaid dedication of the following described land for road purposes be and hereby is accepted:

All that certain piece or parcel of land situate in the Township of Jackson, County of Cambria and State of Pennsylvania, bounded and described as follows:

Beginning at a point on the Southerly side of First Avenue on the Fairfield Plan of Lots as recorded in Cambria County in Plat Book Volume 3 at page 155, at the common corner of Lots Nos. 33 and 32 on said Plan; thence along the line of Lot No. 32 South 35° 46' East a distance of 490 feet to the common corner of Lots Nos. 40 and 41 on Second Avenue on said Plan; thence along the Northerly line of said Second Avenue North 54° 14' East a distance of 33 feet to the line of land of Michael Holub, et ux, grantors herein; thence along line of land of said Michael Holub, et ux, and line of land of William A. Fulton, et ux, grantors herein, North 35° 46' West a distance of 490 feet to a point on the Southerly side of First Avenue; thence along the Southerly line of said First Avenue South 54° 14' West a distance of 33 feet to the common corner of Lots Nos. 33 and 32 and place of beginning; being a portion of Lots Nos. 40 and 33 on the said Fairfield Plan of Lots.

Being a portion of premises, title to which became vested in Walter E. Walker and Emma M. Walker, his wife, grantors herein, by deed of William W. Campbell, et al, Trustees, dated July 29, 1912, and recorded in Cambria County in Deed Book Volume 508 at page 59h.

RESOLVED, further, that said parcel of land be and hereby is laid out and opened as an extension to Poplar Street on the James Mackall Plan of Lots, and the right-of-way width is hereby established at 33 feet.

RESCLVED, further, that the blueprint attached hereto be and hereby is made a part hereof.
