AN ORDINANCE FOR THE ACCEPTING, OPENING AND LAYING OUT OF OAKLYNN DRIVE

BE IT ORDAINED, and it is hereby ordained that the Township of Upper Yoder, Cambria County, Pennsylvania, hereby accepts, opens and lays out as apublic road in said Township Caklynn Drive, being 40 feet in width, more particularly described as follows:

BEGINNING at a point on Meadow Drive approximately 0.39 miles in a Southerly direction from the inter-section of Meadow Drive and Pennsylvania Route 271 (Menoher Highway) and extending South 51° 52' West a distance of 564.63 feet; thence South 45° 15' West a distance of 470.47 feet; thence South 36° 45' West a distance of 163.59 feet; thence South 51° 30' West a distance of 409.41 feet; thence South 74° 11' West a distance of 55.11 feet to a point at intersection of Oaklynn Drive and Woodland Lane (an unaccepted but dedicated street); thence North69° 47' West a distance of 105.94 feet; thence North 52° 32' West a distance of 78.79 feet; thence North 43° 47' West a distance of 51.49 feet; thence North 32° 32' West a distance of 599.02 feet (passing El-Va-Lon Lane a 50 foot dedicated street and Wild Cat Rocks Road a 40 foot dedicated street, the centers of which are 345 feet apart with El-Va-Lon Lane centerline located 100 feet from Station 8+64.33); thence N rth 2° 35' West a distance of 114.35 feet; thence North 0° 12' West a distance of 132.27 feet; thence North 7° 00' East a distance of 124.0 feet; thence North 19° 28' East a distance of 86.03 feet; making a total of 1920 feet from the centerline intersections of Meadow Drive and Oaklynn Drive;

a map, draft and survey showing said Oaklynn Drive and also the centerline grade established thereon, as prepared by Hinks and Locher on August 1, 1960 and August 30, 1960, is attached hereto and made a part of this Ordinance.
