In accordance with the Act of Assembly known as the Second Class Township Code, effective July 1, 1933, and as amended July 1, 1947, and pursuant to Section 1102 thereof, the Supervisors of Conemaugh Township, Cambria County, Pennsylvania, hereby submit to the Clerk of Quarter Sessions of Cambria County, Pennsylvania, a true and correct copy of the Ordinance passed by said Supervisors, the 2nd day of December, 1961, whereby certain streets named in the Ordinance were established as public roads or highways of said Township. There is also submitted herewith a draft or survey of said roads and streets showing the location and width thereof. The text of the Ordinance is as follows:

Ordinance -- The Supervisors of the Township of Conemaugh, Cambria Co., Pennsylvania, hereby adopt and enact this ordinance establishing the following as public roads or highways of this Township with the boundaries, courses and distances, width and termini as shown on map, drawing and profile as prepared for this Township by Hinks and Locher Engineers, Johnstown, Pennsylvania, which said map, drawing or profile is incorporated herein by reference and made a part hereof, and as by reference thereto, the same will more fully and at large appear.

Passed finally this 2nd day of Dec., 1961, after due advertisement and notice to the property owners affected thereby.

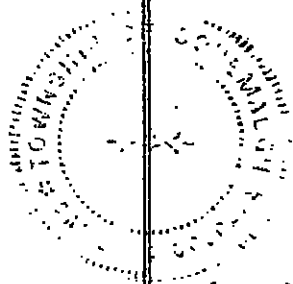
