A RESOLUTION OF THE BOROUGH OF GEISTOWN AUTHORIZING, REQUESTING AND CONSENTING THE COMMONWEALTH OF PENNSYLVANIA TO ADOPT AS A STATE HIGHWAY BENTWOOD STREET AS IT LIES BETWEEN LEGISLATIVE ROUTE 222 and OHIO STREET AS RE-LOCATED.

WHEREAS, the Borough of Geistown has previously requested the Highway Department of the Commonwealth of Pennsylvania to accept as a State Highway Bentwood Street as it lies between Legislative Route 222 (Bedford Street) and Ohio Street as re-located; and

WHEREAS, by Act No. 531, which provides for the adoption of the above recited street; and

WHEREAS, Section 2 of Act No. 531 provides that said public highway shall be adopted if and when the Borough Council consents thereto; and

NOW, THEREFORE, BE IT RESOLVED by the Borough of Geistown that the Borough of Geistown hereby consents to the adoption as a state highway of the following described highway in the Borough of Geistown:

Route 11136 Beginning at the intersection of State Highway application 1591-B (Ohio Street relocated) at Station 85+50 thence in a northerly direction over Bentwood Avenue to its intersection with Legislative Route 222 (Bedford Street) at Station 234+25 a distance of approximately 0.45 mile in Geistown Borough Cambria County;

AND RESOLVED that the necessary Borough Officials are directed to take such action as may be required to see that the above referred to street is duly adopted by the Highway Department of the Commonwealth of Pennsylvania.
