REPORT OF SUPERVISORS OF WEST CARROLL TOWNSHIP

In accordance with provisions of Article XI of the Act of May 1, 1933, P. L. 103, as amended, 53 P. S. 19093-1101 et seq. Ernest Powell, John Nalisnick, John Glinsky hereby make the following report:

That they are the duly elected and qualified Supervisors of West Carroll Township, Cambria County, Pennsylvania.
