AN ORDINANCE LAYING OUT, OPENING AND ADOPTING AS A PUBLIC STREET IN THE VILLAGE OF BELSANO, BLACKLICK TOWNSHIP, CAMBRIA COUNTY, PENNSYLVANIA, A STREET TO BE DESIGNATED AS PENN STREET.

The Township of Blacklick hereby ordains as follows:

SECTION 1. A street, the center line of which is described in Section 2 hereof, is hereby designated as Penn Street and is hereby laid out, opened and ordained as a public street in the Village of Belsano, Blacklick Township, Cambria County, Pennsylvania.

SECTION 2. The center line of said street hereby ordained is described, in accordance with a print of a survey by L. Robert Kimball, Consulting Engineers, dated July, 1964, attached hereto and made a part hereof, as follows:

Beginning at a point in the center of Smith Street in the Village of Belsano, Blacklick Township, Cambria County, Pennsylvania, said point of beginning being located North 77° West, a distance of 562 feet from the center of the intersection of Smith Street and Adams Street; thence North 16° 29' East, a distance of 223.47 feet, more or less, to the center of U. S. Highway Route No. 422.

SECTION 3. The width of said street is hereby established and ordained at thirty-three (33) feet, being sixteen and one-half (16½) feet on each side of the center line hereinabove described.
