## A RESOLUTION

ACCEPTING AS STREETS AND PUBLIC HIGHWAYS OF THE TOWNSHIP OF EAST TAYLOR CERTAIN PORTIONS OF STREETS NOW DEDICATED AND RECORDED IN PLANS OF LOTS, THE FOLLOWING: PASTURE LANE, TIMOTHY AVENUE, ALFA AVENUE, HAYS AVENUE, EAST BINDER STREET, THRASHER STREET, BAILING STREET and CALHOUN STREET, OTHERWISE KNOWN AS THE "OLD STREET CAR LANE."

BE IT RESOLVED, and it is hereby resolved by authority of the Board of Township Supervisors of EAST TAYLOR TOWNSHIP, Cambria County, Pennsylvania, that the following parts of dedicated streets, as shown in the hereinafter referred to recorded Plan, be and the same shall become part of the highway system of the Township of East Taylor:

SECTION A. From the Plan of Lots as laid out by Don J.

Leckey and recorded in the Office of the Recorder of Deeds in and for Cambria

County, Pennsylvania, in Plat Book Vol. 5, Page 7, recorded on April 14,

1952:

- (a) PASTURE LANE, a street 44 feet in width, beginning at State Highway Route 219, also known as Route 72, running South 47° 39' 40" East, a distance of 379 feet; thence running South 55° 41' 40" East, a distance of 992 feet, or the total length of 1,371 feet to the intersection of Highway Route 271, also known as "Park Hill Drive."
- (b) TIMOTHY AVENUE, now known as Oliver Avenue, beginning at Township Route 718, now known as Donruth Lane; thence North 45° 24' 20" East, a distance of 308 feet to the intersection of Pasture Lane, having a width of 44 feet.
- (c) TIMOTHY AVENUE, now known as Oliver Avenue, beginning at Township Route 718, now known as Donruth Lane; thence South 45° 24¹ 20″ West, a distance of 420 feet, having a width of 44 feet.

(d) ALFA AVENUE, beginning at Township Route 718, also known as Donruth Lane, South 45° 24' 20" West, a distance of 330 feet, having a width of 44 feet.

(e) HAYS AVENUE, now known as Barlett Avenue, beginning at Township Route 718, also known as Donruth Lane; thence South 45° 24' 20" West, a distance of 270 feet, having a width of 44 feet.

SECTION B. From the Plan of Lots: as laid out by Don J.

Leckey, which Plan is recorded in the Office of the Recorder of Deeds in and
for Cambria County, Pennsylvania, in Plat Book Vol. 5, Page 108, recorded

April 7, 1959, the following:

- (a) EAST BINDER STREET, now known as East Binder Lane, beginning at the intersection with Highway Route 271, known as Park Hill Drive, leading from the Village of Park Hill to the intersection with State Route 219; thence South 87° 07' 40" East, a distance of 495 feet to Ridge Lane, having a width of 44 feet.
- (b) THRASHER STREET, now known as Thrasher Lane, beginning at the intersection of State Highway Route 271, also known as Park Hill Drive; thence South 87° 07' 40" East, a distance of 495 feet to Ridge Lane, having a width of 44 feet.
- (c) BAILING STREET, now known as Bailing Lane, beginning at the intersection of State Highway Route 271, also known as Park Hill Drive; thence South 87° 07' 40" East, a distance of 420 feet to Ridge Lane, having a width of 44 feet.

SECTION C. From the Woodvale Heights Area Plan of Lots as laid out by Fetterman Engineering Company on July 30, 1908 and recorded in the Office of the Recorder of Deeds in and for Cambria County as A. M. Custer and I. C. Bole Plan of Lots in Plat Book 4, Page 3, recorded May 20, 1946:

(a) Street shown as the Southern Cambria Railway, and now called CALHOUN STREET, also formerly known as "Old Street Car Lane," beginning at the intersection with Township Route 370 and thence in an easterly direction a distance of 1,500 feet, having a width of 40 feet.
