AN ORDINANCE LAYING OUT, OPENING AND ADOPTING AS A PUBLIC STREET IN THE VILLAGE OF TWIN ROCKS, BLACKLICK TOWNSHIP, CAMBRIA COUNTY, PENNSYLVANIA, A STREET TO BE DESIGNATED AS THIRD STREET.

The Township of Blacklick hereby ordains as follows:

SECTION 1. That a street 40 feet in width be and the same hereby is laid out, opened and ordained as a public street in the Village of Twin Rocks, Blacklick Township, Cambria County, Pennsylvania, over and through the following parcel of land:

Beginning at a point on the Easterly right of way line of State Highway Route No. 933 at the Southwesterly corner of property of Joseph Bankovich; thence South 67° 35' East a distance of 416 feet, more or less to Coal Pit Run; thence by Coal Pit Run in a Southwesterly direction 40 feet, more or less, to a point; thence North 67° 35' West 416 feet, more or less, to the Easterly right of way line of said State Highway Route No. 933 and Northwesterly corner of land of Robert A. Lanzendorfer; thence along the Easterly right of way line of State Highway Route No. 933 in a Northeasterly direction 40 feet to the Southwesterly corner of land of Joseph Bankovich and place of beginning. A print of a survey of said street by L. Robert Kimball, Consulting Engineers, dated September, 1965, is attached hereto and made a part hereof.

SECTION 2. That said street be and hereby is designated as Third Street.
