AN ORDINANCE LAYING OUT, OPENING AND ADOPTING AS A PUBLIC STREET IN BLACKLICK TOWNSHIP, CAMBRIA COUNTY, PENNSYLVANIA, A STREET TO BE DESIGNATED AS HEMLOCK STREET.

The Township of Blacklick hereby ordains as follows:

SECTION 1. That a street, the right of way of which is described in Section 2 hereof, be and hereby is laid out, opened and ordained as a public street in Blacklick Township, Cambria County, Pennsylvania.

SECTION 2. That the right of way of the street hereby laid out and ordained is described as follows:

Beginning at a point where the Westerly line of Hemlock Street in the Borough of Nanty-Glo, Cambria County, Pennsylvania, intersects the dividing line between said Borough and Blacklick Township, Cambria County, Pennsylvania; thence North 33° 06' East a distance of 160 feet to the Southerly line of Fifth Street; thence slong the Southerly line of Fifth Street South 57 East a distance of 40 feet to a point; thence South 33° 06' West a distance of 110 feet, more or less, to the said dividing line between the Borough of Nanty-Glo and Blacklick Township; thence along said dividing line in a Southwesterly direction a distance of 66 feet, more or less, to the point of beginning. A print of a survey by L. Robert Kimball, Consulting Engineers, dated September, 1965, of the street hereby ordained is attached hereto and made a part bereof.

SECTION 3. That said street be and hereby is designated as Hemlock

Street.
