TOWNSHIP OF SUSQUEHANNA

ORDINANCE NO. 4-84

AN ORDINANCE LAYING OUT, OPENING AND ADOPTING AS A PUBLIC STREET IN THE TOWNSHIP OF SUSQUEHANNA, A STREET TO BE DESIGNATED AS Walnut Ave. AND FIXING AND REGULATING THE WIDTH AND LENGTH THEREOF.

BE IT ENACTED AND ORDAINED by the Township of Susquehanna, Cambria County, Pennsylvania and it is hereby enacted and ordained by authority of same as follows:

SECTION I

The following street, which is hereby designated as Walnut Ave., is hereby laid out, opened and ordained as a public street in the Township of Susquehanna:

BEING the entire right-of-way known as the Penn Central Right-of-Way; beginning at the boundary line of the Borough of Barnesboro, (Byrnesville) and proceeding through Susquehanna Township to the Village of Cymbria a distance of approximately 7,213 feet. Being the entire right-of-way purchased by the Township of Susquehanna on the 29th day of June, 1981 and as fully described in the Recorder's Office of Cambria County in Deed Book Volume 1059, page 227.

SECTION II

The said street specifications and a map of the plot may be inspected at the Township Meeting Room, Coal Country Medical Center, Allport R.D., Barnesboro, Pennsylvania during regular business hours.

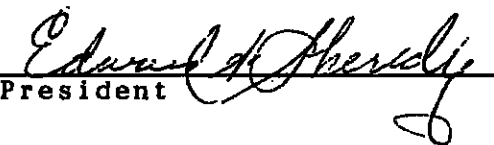
SECTION III
