ORDINANCE NO. 530

'AN ORDINANCE OF THE BOROUGH OF WESTMONT VACATING SERVICE COURT NO. 6 AS SHOWN ON PAGE 82 OF THE BOROUGH OF WESTMONT REGISTRY OF REAL ESTATE.

BE IT ENACTED AND ORDAINED by the authority of the Mayor and the Council of the Borough of Westmont, AND IT IS HEREBY ENACTED AND ORDAINED:

SECTION 1: That Service Court No. 6 as shown on Page 82 of the Borough of Westmont Registry of Real Estate be and is hereby vacated. The said Court is 16 feet wide and 410 feet long running perpendicular to Dundee Lane and bounded by properties fronting on Beaver Street and on Dickinson Street.

 $\underline{\text{SECTION 2}}$: The vacation of Service Court No. 6 is being done pursuant to the requests of all property owners adjacent to the said Service Court.

SECTION 3: All ordinances, or parts of ordinances, in conflict with this ordinance shall be, and the same are hereby repealed.


