At the duly scheduled meeting of the council of the Borough of Lilly held on March 2, 1989, upon motion of John Nezneski, councilman, seconded by Frank A. Stopka, Jr., councilman, and unanimously passed, it was **RESOLVED THAT** the attached plan of a piece or parcel of land to be conveyed to the Borough of Lilly by way of a Deed of Dedication was approved in recognition that Church Street requires straightening, a public hearing thereon was waived and the Secretary of the Borough, E. Beverly Mandichak, was designated as the appropriate officer to file the plan in the Borough office and make the same available for public inspection at all reasonable times up to and including the final passage of an Ordinance accepting said Deed of Dedication, all this pursuant to Sections 46741, 46751 and other appropriate Sections of the Borough Code, 53 P.S. 45101, et seq., and other applicable laws.

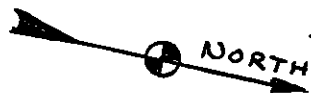

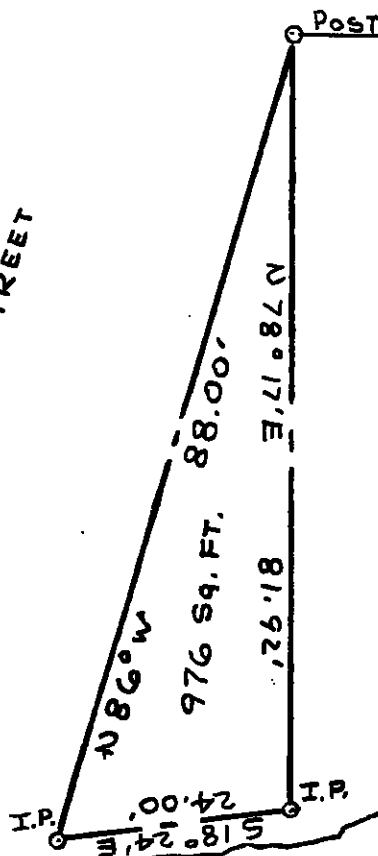

FOR

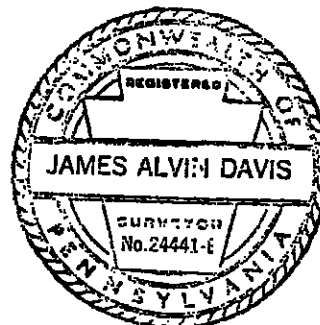
