RESOLUTION 2001 - 1015

RESOLUTION OF ADAMS TOWNSHIP
BOARD OF SUPERVISORS DECLARING CERTAIN ROADS
AS PUBLIC ROADS PURSUANT TO SECTION 2307
OF THE SECOND TOWNSHIP CODE

WHEREAS, certain roads in Adams Township, Cambria County, have been used for public travel, maintained and kept in repair by the Township of Adams for the last twenty-one (21) years;

WHEREAS, those roads are more specifically identified in Exhibits "A" through "K" attached hereto and made a part hereof; and,

WHEREAS, the Township of Adams desires to declare those roads as public roads having rights-of-way of thirty-three feet (33') feet in width for purposes of obtaining Liquid Fuels Tax reimbursement.

NOW THEREFORE, the Board of Supervisors of the Township of Adams has resolved and hereby resolves as follows:

1. The Township of Adams, pursuant to the provisions of the Second Class Township Code, Act 60 of 1995, Article XXIII, Section 2307 hereby declares the roads specifically described on Exhibits "A" through "K" attached hereto and made a part hereof, as public roads for the benefit of the public, having rights-of-way of thirty-three feet (33') in width, for purposes of Liquid Fuels Tax reimbursement.

2. A certified copy of this Resolution shall be filed and recorded in the office of the Clerk of Courts of Cambria County, Pennsylvania.

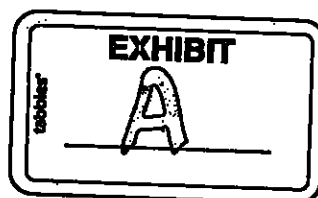
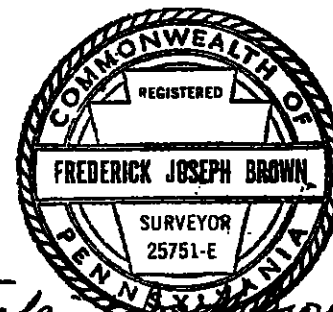
RAILROAD STREET, DUNLO, ADAMS TWP. Description for road dedication

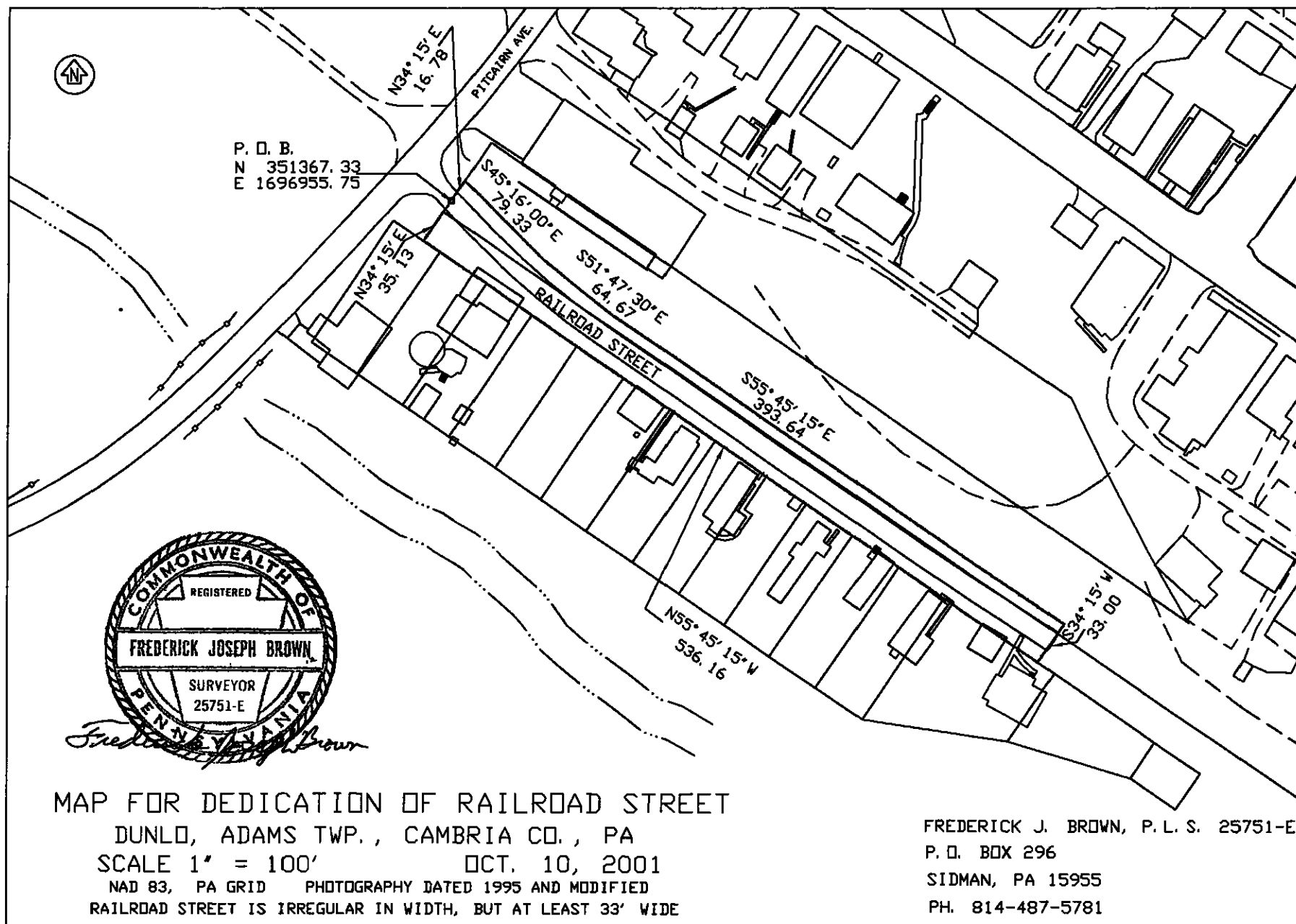
Beginning at a point which is located on the east side of the right-of-way of Pitcairn Avenue, said point having NAD 83 PA Grid coordinates of N 351367.33 and E 1696955.75; thence along the east side of Pitcairn Avenue North $34^{\circ} 15'$ East 16.78 feet to a point; thence along the north side of Railroad Street the three following courses and distances:

- (1) South $45^{\circ} 16' 00''$ East 79.33 feet to a point;
- (2) South $51^{\circ} 47' 30''$ East 64.67 feet to a point;
- (3) South $55^{\circ} 45' 15''$ East 393.64 feet to a point;

thence along the east side of Railroad Street South $34^{\circ} 15'$ West 33.00 feet to a point; thence along lots in the Plan of Dunlo North $55^{\circ} 45' 15''$ West 536.16 feet to a point; thence along the east side of Pitcairn Avenue North $34^{\circ} 15'$ East 35.13 feet to a point, the place of beginning.

Railroad Avenue is irregular in width, but at least 33 feet wide.

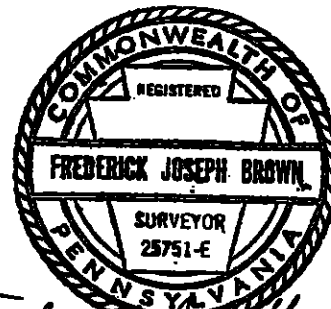
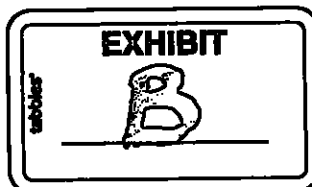

ALSO, beginning at a point being the end of the first course in the above description; thence from said point the three following courses and distances:

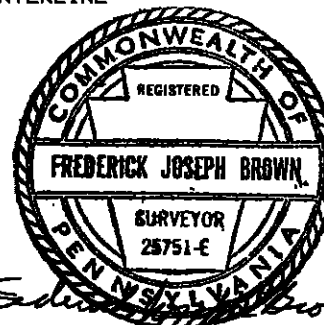
- (1) North 70° 03' West 36.84 feet to a point;

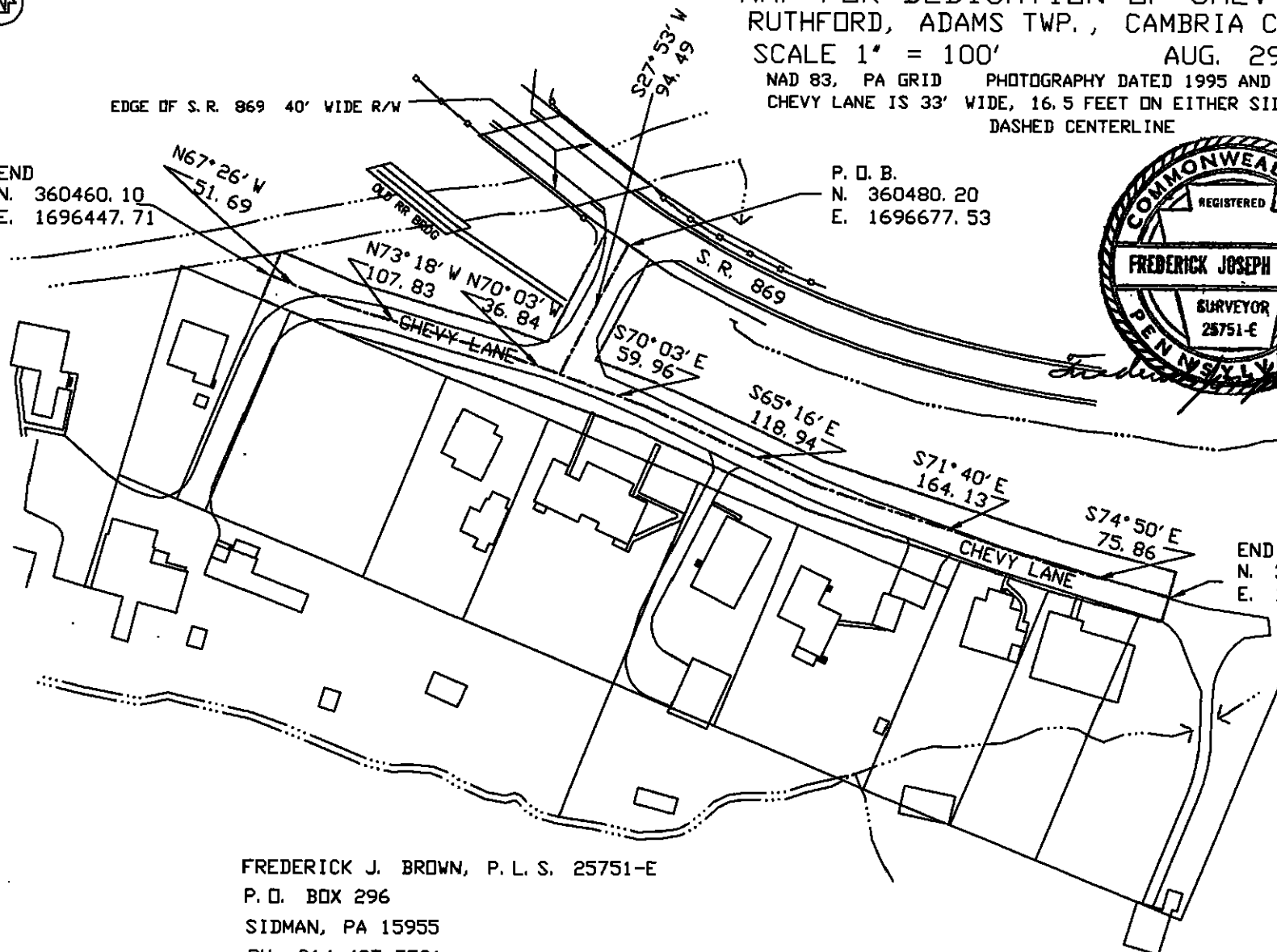
MAP FOR DEDICATION OF CHEVY LANE

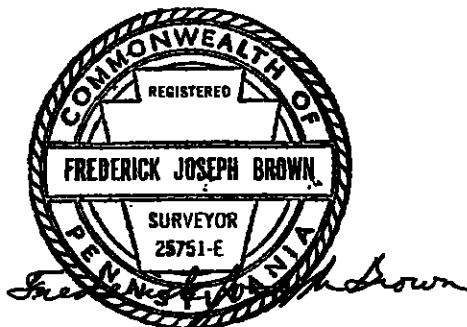
MAPLE STREET, SIDMAN, ADAMS TWP. Centerline description for dedication

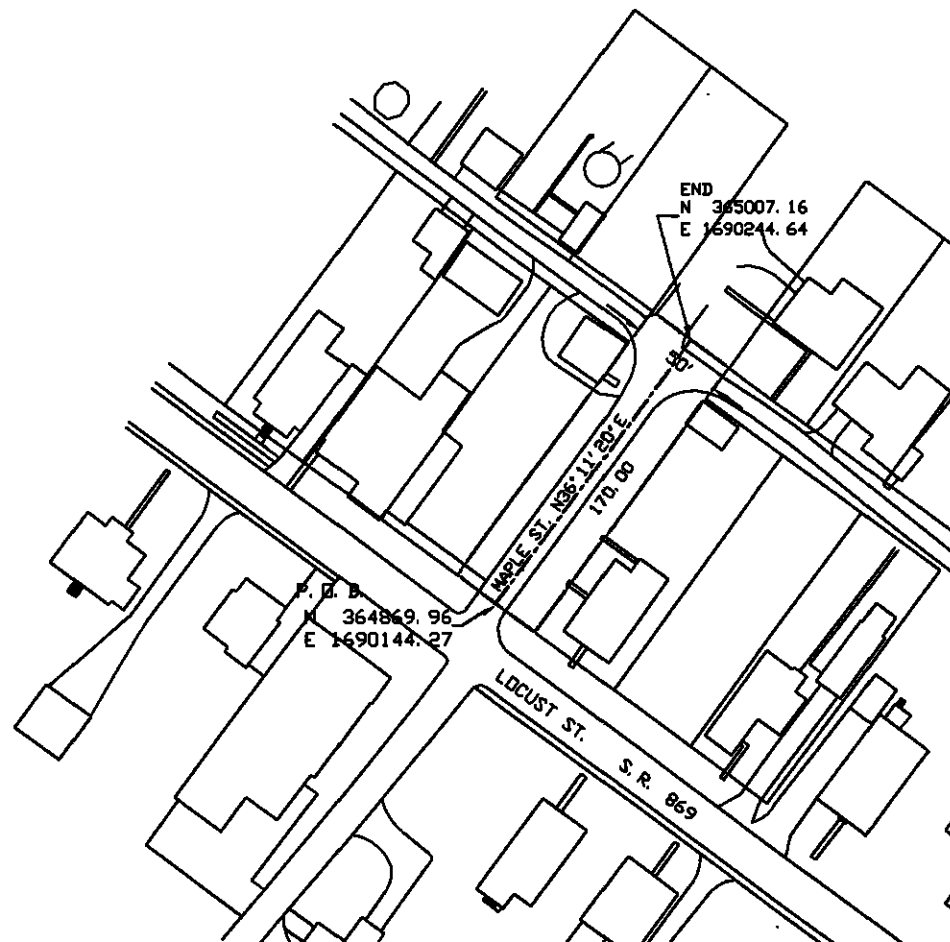

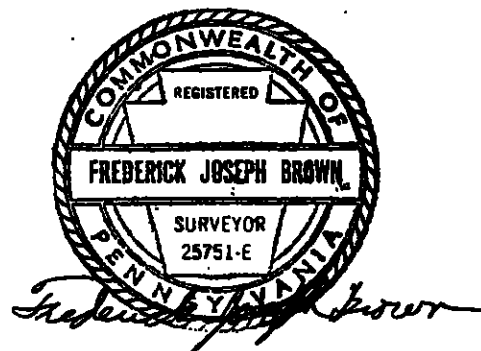

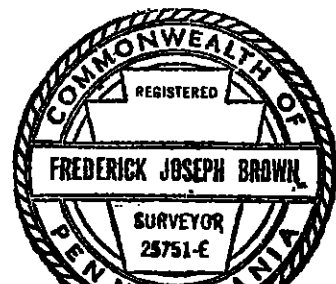

Franklin Street is 40 feet wide, 20 feet on either side of the above described centerline.

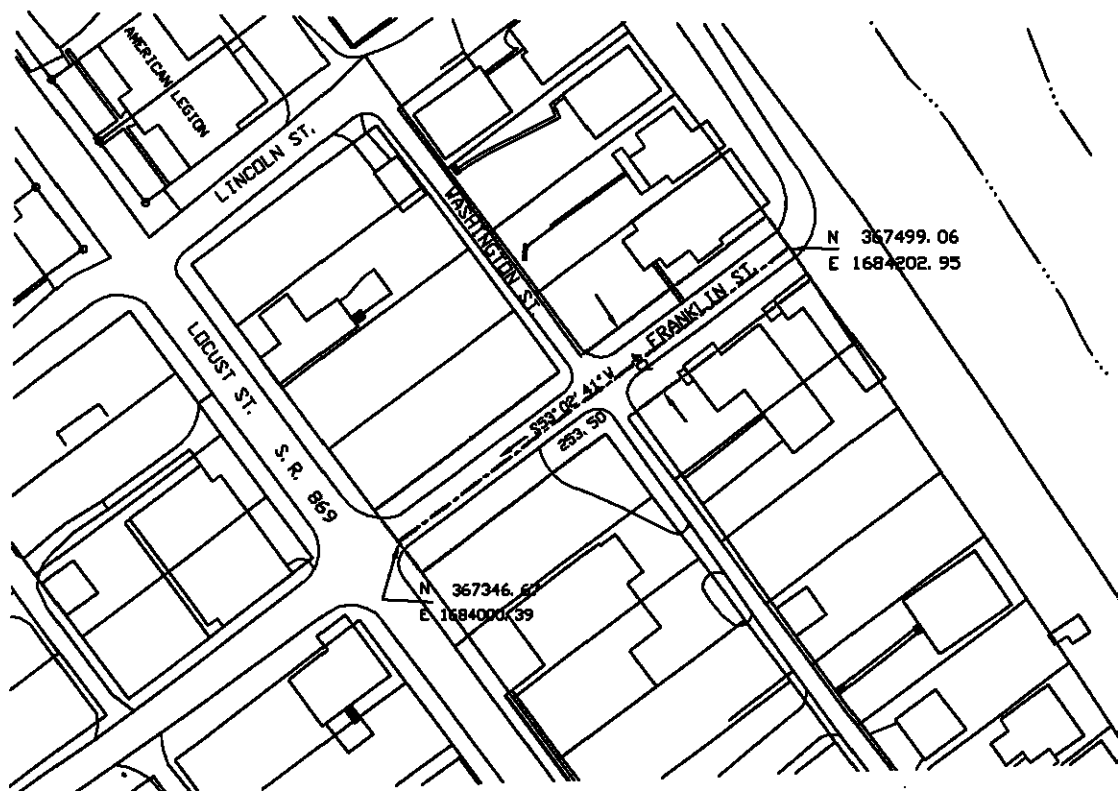


MAP FOR DEDICATION OF FRANKLIN ST.

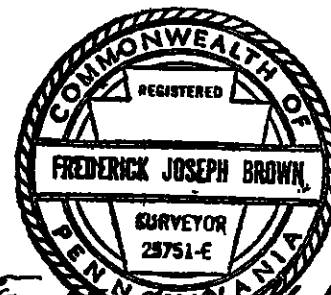

Utzman Development of Beautyline Park recorded June 18, 1973; thence along the baseline of Mary Drive and further along the baseline of Maxine Drive the four following courses and distances:

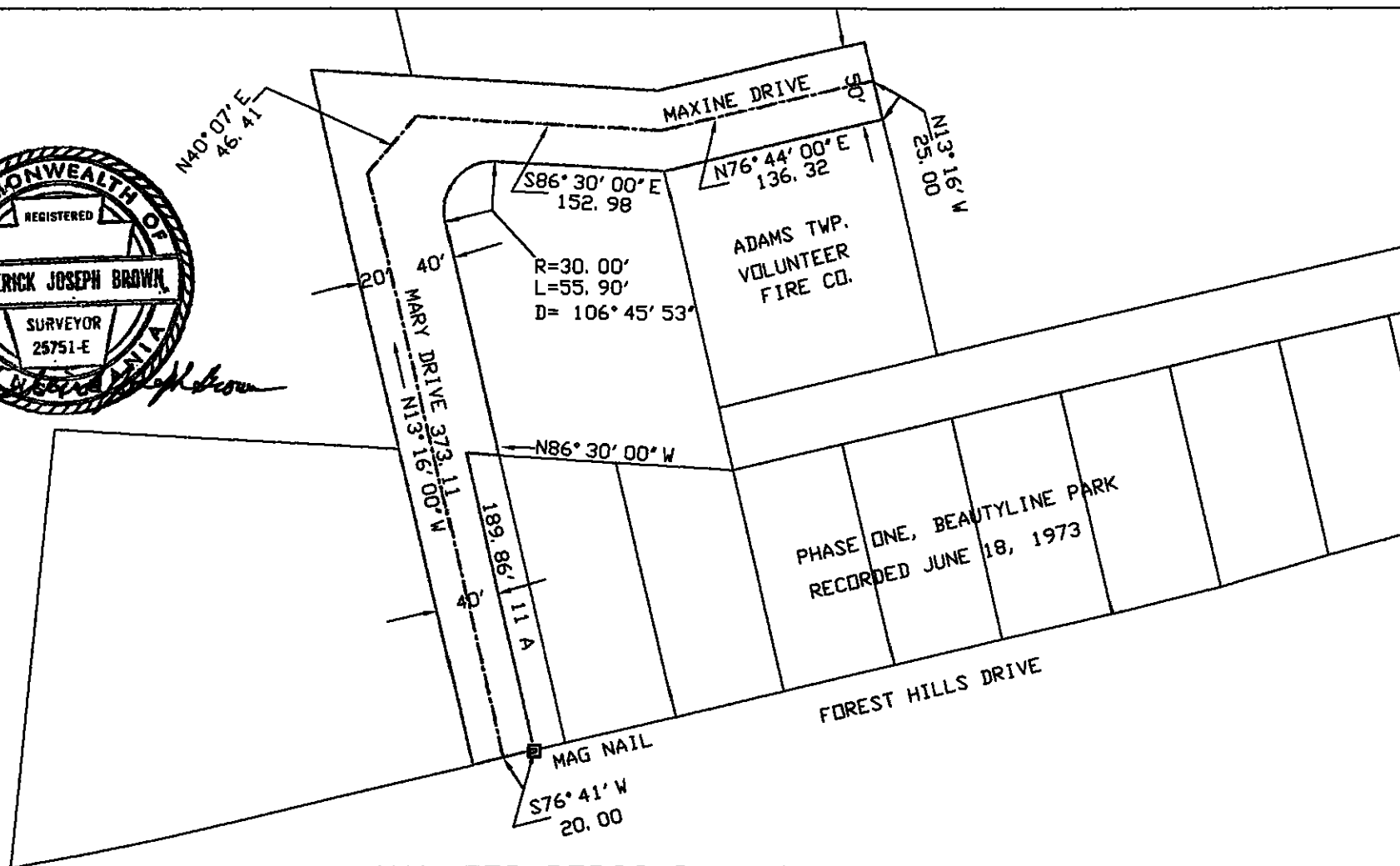
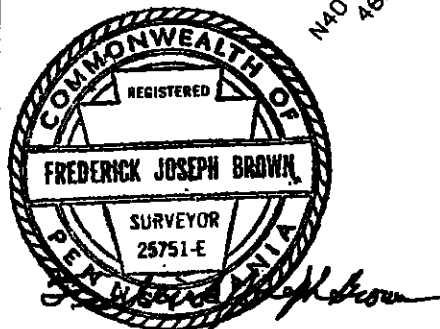
- (1) North $13^{\circ} 16' 00''$ West 373.11 feet to a point;

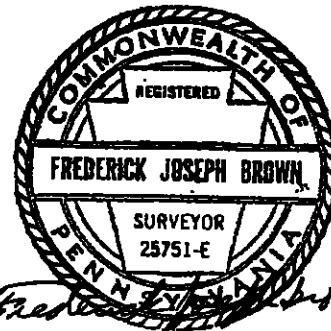

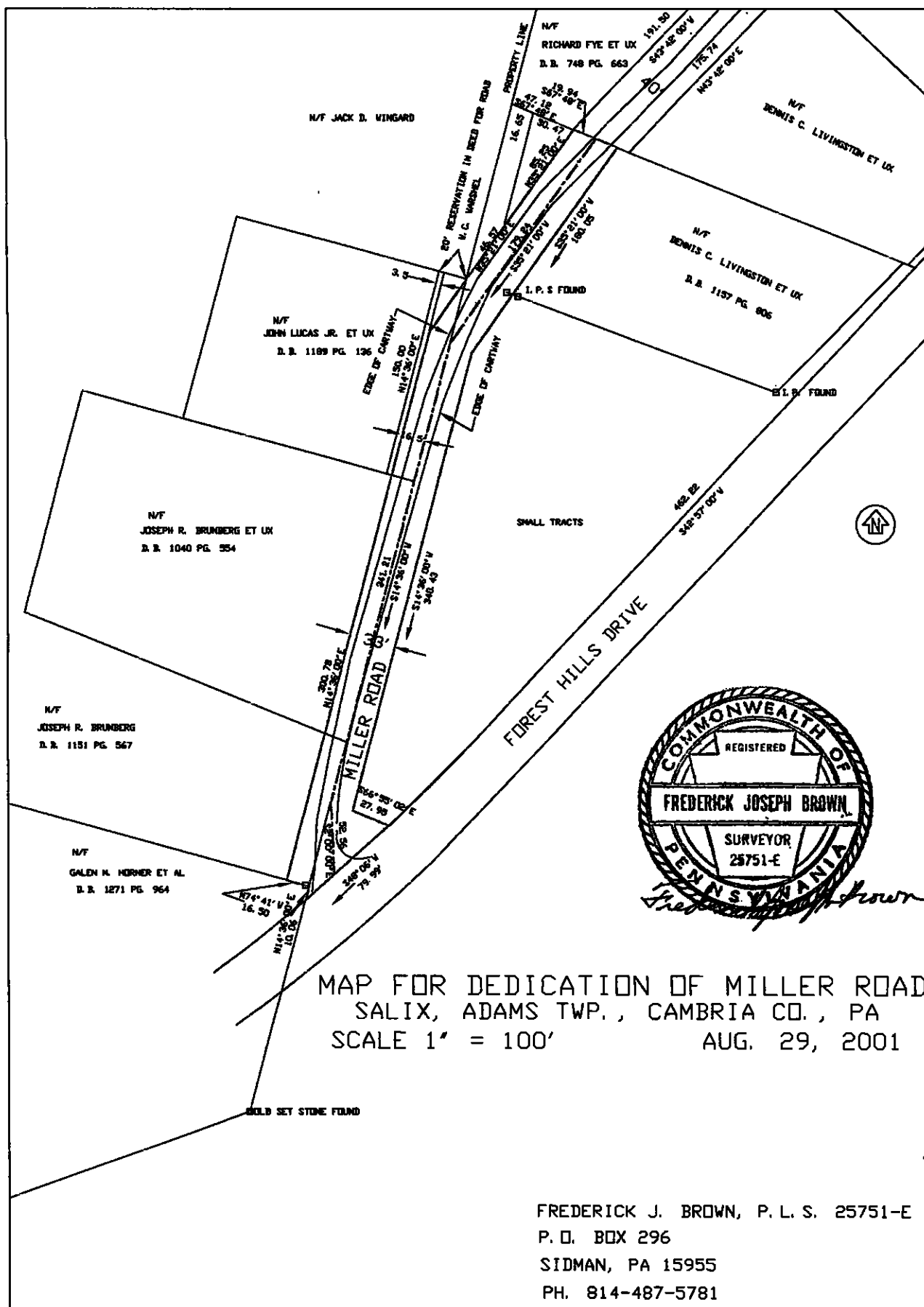

This part of Miller Road is at least forty feet in width.

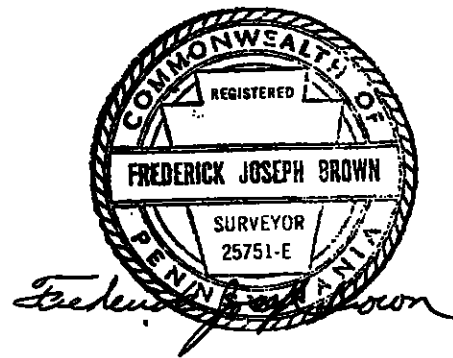
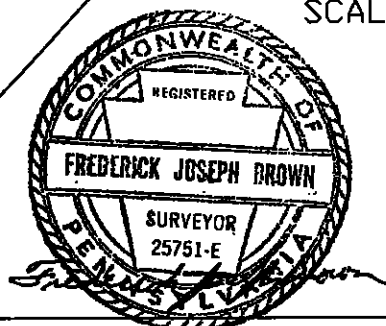
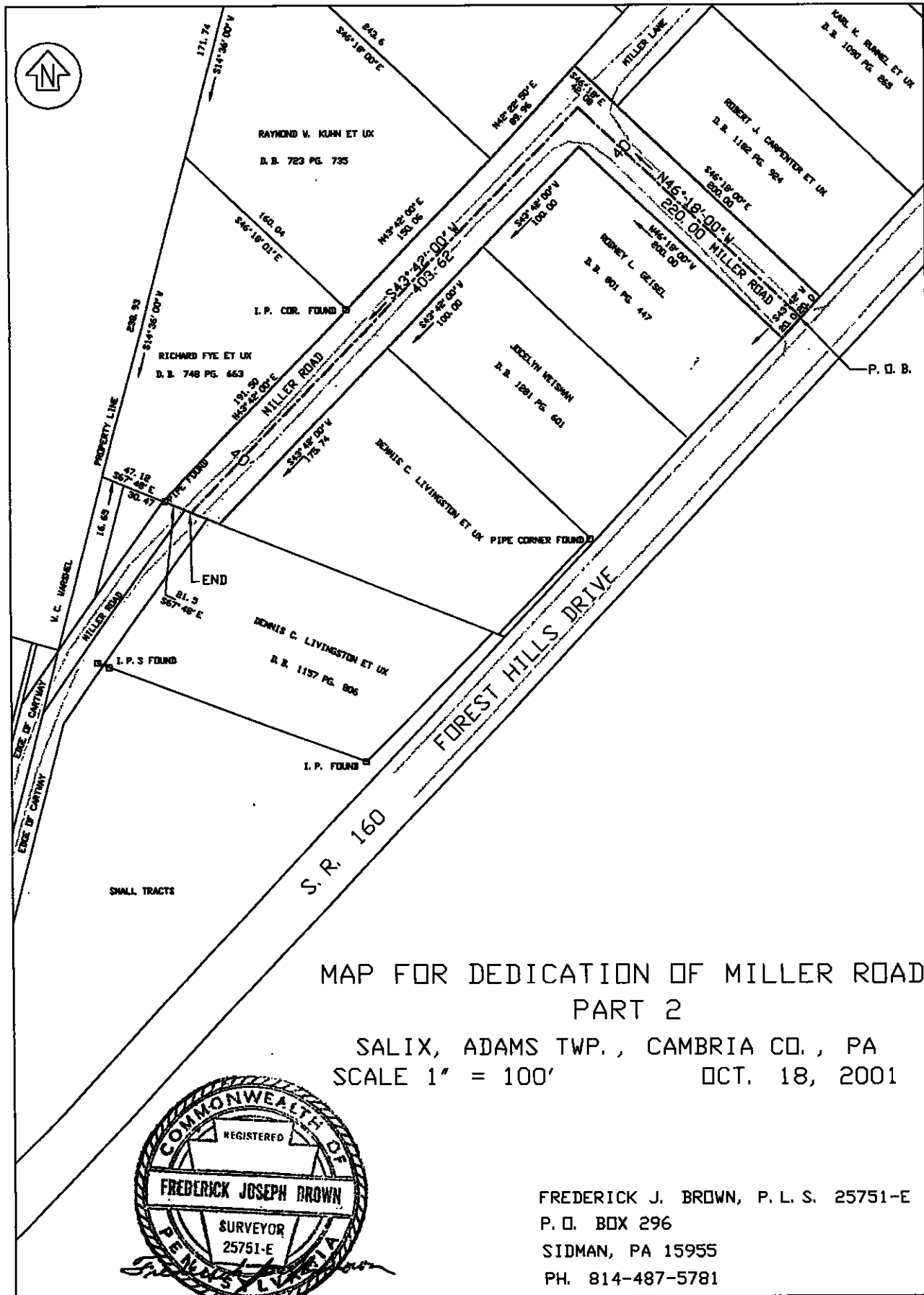

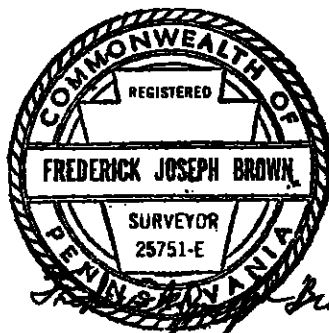

Miller Lane varies in width as shown on the attached plan.

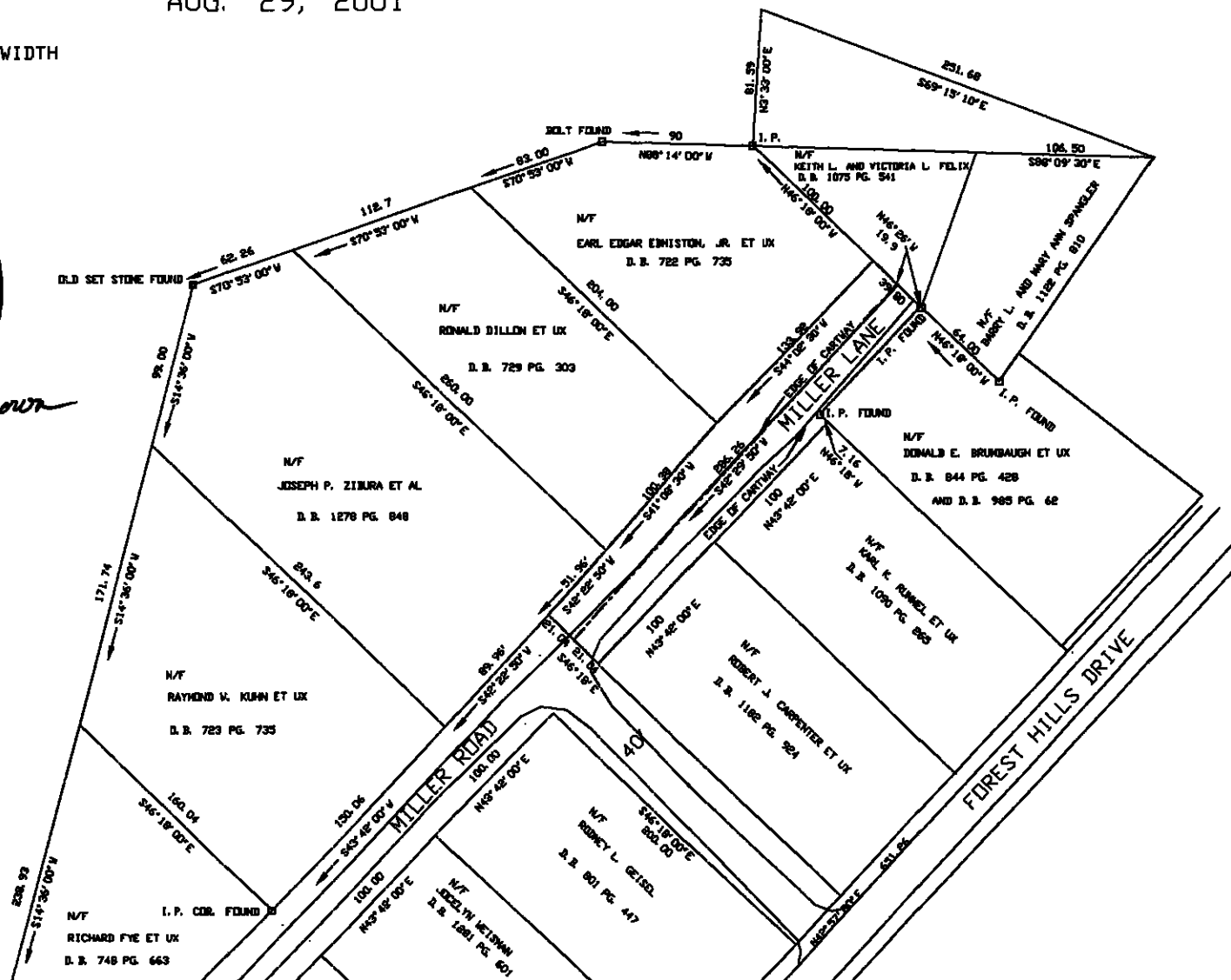


MAP FOR DEDICATION OF MILLER LANE
